Since becoming Queen's (now King's) Counsel, James has practised internationally – and in particular in the Caribbean – in the field of cross-border disputes. He has been admitted to practice in 11 (shortly to be 12) jurisdictions. He has advised or appeared in commercial claims of every description, including development contracts, intellectual property, company law and shareholder disputes and insolvency. He is also a recognised authority in matters relating to or involving trusts.
