His expert evidence has been given in the context both of litigation and arbitration.

His "big ticket" contentious insolvency experience includes the Baha Mar resort in The Bahamas. He is also a Fellow of the Chartered Institute of Arbitrators.

His public law work has covered a wide range of judicial review and constitutional issues. His 2024 victory at first instance on a constitutional claim for a same-sex couple was upheld by the Turks and Caicos Islands Court of Appeal in September 2025.

His Death Row work has included the USA (Texas) and the Caribbean region.

Tim relishes "pointy-end" court work and related litigation. He is a member of the of the Human Rights and Rule of Law Committee, Commonwealth Lawyers Association.
